#### 13 DESCRIPTION OF EQUIPMENT

In-head Temperature Transmitter Model IPAQ C330X is a loop powered device that converts the measurements signals of temperature sensors (RTD or thermocouple) or resistance or mV signals into a 4 - 20 mA output signals with HART communication.

The transmitter is designed to be mounted in to a Form B or larger connection head according to EN 50446 / DIN 43729.

The transmitter is provided with a USB port and NFC technology for service and configuration.
